In the last two years as Public Outreach Coordinator for NYN, I feel we have made real progress. Our goal is to attract all families and friends of alcoholics to Al-Anon Family Groups, so that everyone who needs our program can find help and hope in their community. More and more, I believe, we are accomplishing this. In my final year, I am hoping we can get even more fresh faces involved in our outreach attempts.

- A final reminder: the deadline to order the second printing of "AFA 2017" is February 8<sup>th</sup>, 2017, 5 p.m. ET.
- March 4<sup>th</sup> is Lois W.'s birthday. We can celebrate our cofounder by remembering to "forget" as we leave copies of *Al-Anon Faces Alcoholism*, or any other piece of public information literature, at medical facilities, professionals' offices, break rooms, waiting rooms, and other public places.
- April is "Alcohol Awareness" month. I
  know it seems far away right now, but if we
  start talking and planning now we will be
  better prepared to participate. Consider
  working with your local library. See if they
  will welcome a display of public outreach
  materials.
- Al-Anon is now on Instagram. Find us on Instagram by following and liking our posts or click on the link located on the WSO Public Outreach website, al-anon.org

Brian, our Public Outreach Coordinator for the Rochester AIS, and his committee have been busy. Here are a few things that they are or have been up to:

- A presentation by Al-Anon members will soon be offered at Pre-Trial Services for people who have been charged with a DWI. As of right now it looks as if we will be meeting bi-monthly.
- Every other month, a First Step meeting is being brought to Jennifer House, a residential program for women and their children. Jennifer House serves homeless women with a criminal history who are entering the community from jail, in-patient facilities, the streets and other homeless situations.
- At Unity Hospital a couple of members shared their experience, strength, and hope with families and friends of alcoholics that are in recovery. Outreach literature was brought in and my understanding is that the Hospital would like this to be done on a monthly basis.

 Members are going, on a monthly basis, to FLACRA, Finger Lakes Addictions Counseling & Referral Agency, to share their experience.

Kelli, our new Public Outreach Coordinator for WNY AIS, had a conference call on Sunday, January 8th. Kelli had formed a committee and invited me to participate in the call.

- Each person on the committee has taken on a role; from sending out sample letters, (available on the members' site), to school counselors, physicians, counseling centers; and also enclosing our AFA's along with their personal message.
- Members continue to partake in the family recovery program at Erie County Medical Center, ECMC.
- We will have a table at a health fair in Buffalo this March.
- Our next conference call is February 5<sup>th</sup>.

(Kelli and her committee are off to a great start!)

#### From District 8:

- Outreach flyers geared to parents and to the general public were distributed to the GR's.
- Participation in a health fair at St. Rose
  College this past year brought this
  surprise—
  100 percent of the students who came to
  the table did <u>not</u> want written material but
  chose only to capture some info with their
  phones.
- Members found that the use of the term "Al-Anon" was confusing to the students, who thought it meant AA. (The district is redoubling their commitment to use the term "Al-Anon Family Groups" in outreach efforts.)
- Participation in a panel discussion at a senior living center in Rotterdam may have sparked interest in starting a new group.
- Packets were mailed to individuals who asked for information by contacting the district via email.
- Two queries about Alateen were received but, sadly, there is no area Alateen group to refer them to.

No word from WSO on the new PSA's; when I receive that information I will be in touch.

What is happening in your area of NYN?

Together we can make a difference.

## **Alateen Coordinator**

Hello and Happy 2017,

I hope that everyone had a great holiday season. I was so happy to see that this month's topic is saving Alateen. Some of you may not be aware that Alateen is celebrating its 60<sup>th</sup> anniversary this year. What a better way to celebrate than to make our local communities aware of what the Alateen program is all about. Since my last report, I am happy to say that we are working on many different things to try to spread the word about Alateen. We have developed a strong Alateen Sponsors Committee made up of Sponsors, NYN Officers and Coordinators, as well as members of our Alateen groups. The primary focus of the committee is to develop strategies for making the community aware of Alateen, educating our current AMIAS's (Al-Anon Members Involved in Alateen Service) about their responsibilities and how we can make our current Alateen meetings stronger. Our goal is to meet on a quarterly basis, to discuss what is working and not working within our individual areas.

The following is a breakdown of the various projects we are working on as a committee:

- We have come up with an announcement to be used for posting Alateen meetings to local newspaper and TV station calendars of events.
- Opening a line of communication between sponsors, so that we can support each other and share suggestions.
- Researching a conference phone line that we can use to meet as a committee in between our face-to-face meetings. This

Northern Hi Lights Volume 45 Issue 1 line will also be available to any other committees within NYN.

- Jill C. from our Auburn Alateen Group wrote a fantastic press release article titled "What Is Alateen." I submitted the article to World Service for review, and am happy to report that they gave us the approval to go forward.
- I am submitting a proposal to NYN Assembly to split the current Alateen Coordinator's position into two positions. The Coordinator position would handle conflicts within groups, updating our NYN Alateen Guidelines as needed, and educating all new and current AMIAS's as to their responsibilities. The AAPP (Area Alateen Process Person) would handle the processing of paperwork for registering new Alateen Groups and new AMIAS's, and the annual recertification process. The AAPP would also process any changes to information about Alateen Groups or AMIAS's, such as address changes, meeting time changes, inactivating groups or AMIAS's as requested.
- We discussed World Service allowing each Al-Anon Area the opportunity to assign someone to assist the Area Alateen Coordinator in conducting the annual Alateen AMIAS Recertification Process. I have someone who is considering signing up to assist me, and if she finds that she can handle this function, she is willing to stand for the AAPP position if approved at the next AWSC Election Assembly. By having the second person, it will allow me to focus on educating all AMIAS's in NYN, along with attempting to complete the updating of our current NYN Alateen Guidelines.
- We want to work with the NYN Website
  Coordinator to create an Alateen page on
  our NYN Website. The link will include
  information about Alateen, and a list of all
  Alateen Meetings in NYN. We would like
  this to be a one-stop location for teens who

- January/February 2017 are seeking information about the Alateen program.
- Members of the group expressed an interest in becoming trainers to assist in presenting the Alateen Education Module to all current AMIAS's in NYN.
- Patty H. announced that World Service is about to release a Public Service Announcement for Alateen. Once released, the committee will discuss who will work on having it sent out to all local radio and TV stations.

I will be submitting the minutes from our Alateen Outreach Meetings to the NYN Website Coordinator so everyone can see what is being done in an effort to save Alateen in NYN. I will also be mailing copies of the minutes and outreach document to all Alateen Groups so that they can make their communities aware of the Alateen Meetings in their area. If anyone is interested in becoming a part of this committee, or wishes to assist in any way, please do not hesitate to contact me at Alateen@nynafg.com.

Once strong and numerous, Alateen groups are dwindling in membership and groups are closing. One thing that still seems popular is NYNAC. The members in the groups still want this to continue. This annual conference allows members to meet other members from outside their immediate geographical area, and do some networking. Sadly, the numbers attending NYNAC each year are also dwindling. ## **Presentation Coordinator**

I have reason to believe that if Alateen hadn't been available to me when I was growing up, I would not be typing this article. I remember magnificent, chaotic, inspiring Alateen conferences back in the 1980s, with 600 teens in attendance. I remember feeling like I belonged to something very cool, where I got to hang out with the cool kids. I think that feeling saved my life a couple times. Therefore Alateen's decline has caused a lot of sadness for me personally.

I began serving as an Alateen sponsor myself about 15 years ago, and instantly noticed a difference from when I had been a teen. There were significantly fewer teens coming to meetings. The conferences had shrunk to under 100 attendees. Al-Anon members seemed older, which meant they didn't have teens living in their homes. This seems to have lessened a lot of members' incentive to support Alateen.

I don't serve as an Alateen sponsor anymore, in part because I am deeply uncomfortable with the lackadaisical way Al-Anon treats potential liability for Alateen sponsors. Our safety guidelines protect AFG, Inc., but they don't protect the people in the rooms with the teens, and most Al-Anon members are unable or unwilling to provide the type of support needed to keep everyone in an Alateen room safe. I also recognize that parents are not comfortable leaving their teens in a room for an

hour, week after week, with people they've never met and with whom they had no hand in vetting—nor should they be.

One possible solution is using technology. It is not that difficult to set up a telephone or video conference. We could use technology to rejuvenate not only Alateen meetings but Al-Anon meetings, making them accessible and convenient for busy young parents, who could then get their teens involved in Alateen. Maybe it would be uncomfortable for a while. It would require us to step out of our comfort zones and let go of some preconceived notions about what a meeting looks like. Luckily the Al-Anon Steps, Traditions, and Concepts teach us how to do just that. I think it would be worth it.
