Adirondack Mountains. That was the beginning of a wonderful weekend where I was able to reconnect with old friends and make new ones as well. Thank you District 5 and 22 for a great job as hosts.

During the Assembly we heard the Delegate's report on the happenings of the 2013 World Service Conference (WSC). A few of the items in the report that left an impression on me were:

- If the groups that did not contribute to AI-Anon Family Groups Inc. would each contribute just \$1.00 a month/ \$12.00 a year, that would account for a \$75,000.00 increase in contributions; and that if the groups that do contribute would each give an additional \$12.00 per year to AI-Anon Family Groups Inc., that would account for approximately \$113,000.00 in added revenue.
- The other was related to the policy changes regarding Anonymity and Public Relations. I see the policy changes as a direct impact of the changing world around us.

The two Chosen Agenda Items at the Conference also resonated with me. They were:

- "How can we get districts without District Representatives (DRs) and few Group Representatives (GRs) to become re-involved in participating in Assemblies and the Area World Service Committee (AWSC)? How do we reach out to registered groups who do not attend Area events?
- The other was that, AI-Anon is not growing due to not retaining newcomers and the attrition of old-timers.

During the assembly, New York North (NYN):

- Formed a task force to address one of the Chosen Agenda Items, and several members agreed to work on the task force to reach out to districts that are not active in the NYN Area Assembly.
- We filled our Website Coordinator and Public Outreach Coordinator positions and found a host for the spring 2015 Assembly/Convention. John O. from District 2 is our new Website Coordinator and Marie N. from District 5 is our new Public Outreach Coordinator. Congratulations to both on their new service positions and thanks for stepping up to service at the Area level.
- Thank you goes out to District 10 for volunteering to host our Spring 2015 Assembly/Convention.
- The GRs voted to adopt "Opting in to receive the hardcopy of the newsletter." The motion

was: to publish in three consecutive newsletters that if groups and individuals want to continue to receive the hard copy of the *Northern Hi Lights* they would need to notify NYN and also confirm their mailing address. (See notice on page 1 in this newsletter.)

Our Presentation Committee did a great job presenting Knowledge-Based Decision Making (KBDM). They used the newsletter delivery method as an example of how KBDM and Framing work. Special thanks go out to all the new Group Representatives for participating in the presentation. Participation is truly the key to harmony.

This Assembly marked the middle of the term for Panel 52, and NYN policy states: "An Area Inventory will be done once every three years at the second Spring Convention/Assembly after elections (middle of term) to look at the Area's character defects, what needs to be improved and to take action." Copies of the inventory form were distributed at the Spring Assembly. Results will be compiled and reported on for the Fall Assembly and published on the website.

If you weren't able to attend the Assembly, check the website for reports from the Officers and Coordinators. The presentation on KBDM is also available on the website.

Sharing this month is on "Principles above Personalities." Tradition Twelve states, "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities." To me, principles above personalities means not worrying about where or who the message comes from. It's about "hearing the message." It's about not judging a book by its cover. It's about the contents of the book or "the message." In AI-Anon we come together to share our experience strength and hope in dealing with the disease of alcoholism. It doesn't matter if the person I hear the message from is someone I would have never crossed paths with outside of AI-Anon. It doesn't matter if I dislike like the person or if my views on life are different from theirs. I can place principles above personalities by being honest, open and willing to listen and learn. I can embrace our differences and know that we share a common bond, the affects of alcoholism.

Dear NYN Friends,

Well, the Spring Assembly/Convention in Lake Placid was a week ago. It has taken me the better part of this week to rest from the weekend. It was a great weekend! There were so many people I only get to see twice a year. I met many new people who were attending their first Assembly. The Committee did a great job. Meeting both old and new friends was a wonderful treat.

I wanted to thank everyone for so patiently listening to my report. It was long, and there was a lot on information to pass on to those in attendance. I was so nervous last year, my first report, but this year I was much more comfortable. Next year's report should be a breeze.

I have two things I want to follow up on from my report last weekend:

1. A Thought Force was formed to look at how the Area can reach out to those "Dim and Dark" Districts in the Area and welcome them back into Area activities. There were nine of you who volunteered for this Thought Force. While I have contact information for many of you, there are a couple of you whom I do not have contact information for. Please, if I don't have your contact info send it to me at delegate@nynafg.com. I will be contacting everyone in a week or so to begin working on our task. Thank you all for volunteering.
2. During my report, I shared that the World Service Office (WSO) was going to be conducting another survey of members. This survey would be to measure members' level of involvement in service work. I now have more information I would like to share with all of you. **The survey, "Readiness for Step Twelve" will be open from May 13, 2013, 12:00 AM – July 21, 2013, 11:59 PM ET. The WSO is seeking participation from both members involved in service, and those who are not.** A few notes about the survey:
 - The survey will be open to Al-Anon members in the U.S., Canada, Puerto Rico, and Bermuda.
 - It will be posted on the Members' Web site, www.al-anon.alateen.org/members, in English, French and Spanish.
 - Members' anonymity and confidentiality of their e-mail addresses will be protected.
 - Results will be available in September 2013 and posted on the Members' Web site.

Further information on this survey will be found in the *Forum*. I took the survey a few days ago; it was easy and took less than 15 minutes. I hope all will take part in this survey.

This month's theme is "principles above personalities." I began to really look at and use this concept when I first became involved in service. I began to have some healthier relationships and to learn to work towards a common goal rather than reacting in a negative way when someone "pushed my buttons." At one point early in my service path, I was working on a project with someone who did "push all my buttons." Every trip I made to and from our meeting, my mantra was "principles above personalities." This went on for over a year while we worked together. It worked, we were able to meet our goal and be successful on the project. I can't say that this person still doesn't "push my buttons;" that's my issue, but I don't think she ever knew it. I always try to remember all those trips in the car and my mantra of "principles above personalities."

This month's topic is principles above personalities. This used to be a hard idea for me to grasp. I believe that I had to really grow in the program before this one made any sense to me. I started to get an inkling of what it might really mean when I heard it in the AI-Anon suggested closing put this way, "After a while, you'll discover that though you may not like all of us, you'll love us in a very special way – the same way we already love you." People can rub any of us the wrong way. They may not mean to or they may not even be aware that this is indeed the case. Our program teaches us that we all need to practice acceptance. When I first came to meetings in New York North, lots of people didn't like me. One special person took the time to get to know me and show me, through example, some of the errors of my thinking. I still have a lot to learn and I still make mistakes all the time.

I believe that the principles over personalities idea is that we can all go to assemblies, conventions, meetings and other AI-Anon events and even if we do not care for someone else's opinion, or behavior, the challenge for us is to listen with an open mind and give them the dignity to be themselves. I have learned in AI-Anon that even a newcomer can be the messenger, as long as my mind is open and willing to listen.

Immediate Past Delegate:

As I thought about this month's topic, "principles above personalities;" the first question I had was, what are these principles? So, I went on my usual hunt through our literature to uncover this information. My search took me to three of our hard covered books, two of which are no longer in print as hard covered. The first book that I looked at was *Paths to Recovery*, which for me has become my go-to book on the Steps, the Traditions and the Concepts. It is here that I believe we can begin to uncover the principles of the AI-Anon program. In two specific places I found a direct reference to the principles of the program. The chapter on Step Twelve speaks about "Having had a spiritual awakening as the result of these Steps, we tried to carry this message to others, and to practice these principles in all our affairs." In a member's sharing on page 123, the following principles are identified: honesty, compassion, love, trust, humility, willingness, forgiveness and freedom. In the "Introduction to the Twelve Concepts" on page 248, the key principles found in the Concepts are: ultimate responsibility, delegated authority, leadership, participation, acknowledgment, rights, delegation, balance, and spirituality.

A further search in *AI-Anon Faces Alcoholism* reveals a section entitled, "The Working Principles." Contained in this section: The Nature of the Fellowship, The Twelve Steps and the Twelve Traditions of AI-Anon and Alateen and other tools of the program including the slogans, the serenity prayer, sponsorship and conference approved literature (CAL). And then, in *Having Had a Spiritual Awakening* on page 173, "The Working Principles of AI-Anon." The principles listed here include: acknowledgement of a dependence on a Supreme Being, love of our fellow man, an awareness of the need to improve ourselves, and a willingness to help others.

These are but the main principles we uncover as we read and discuss the Twelve Steps, the Twelve

Traditions and the Twelve Concepts. It is when we apply the meanings found within these principles to the problems within each of our lives that we truly come to understand their benefit in changing our lives for the better. Changing our attitudes and thinking in relation to others is what is key in the use of these principles. ***It is in placing the principles which I am learning about in this program above the personalities of each of the persons that I am brought into contact with that will aid me in becoming a better person.***

This is not something that happens overnight, but rather is an ongoing, everyday effort on my part to study, absorb and then put into practice what I am learning.

My ability to accomplish these changes is dependent upon my willingness to attend my AI-Anon meetings, to read the literature, particularly on the Three Legacies, and to have conversation with members who are also trying to bring about these changes in their lives. I believe my willingness to do service will provide me with opportunities to see and understand how these principles can work in my life. I look forward to our new workbook on the Three Legacies, *Reaching for Personal Freedom – Living the Legacies* due out this coming July. This will be a new aide in helping us understand these principles and having changed attitudes.

Practicing the "principles" of the AI-Anon program is what keeps me coming back. When I look back on where I came from to where I am today; I am able to see my need to continue this beautiful journey of recovery. Today I like who I am becoming; happy, joyous and loving.

Literature Coordinator:

Hi Everyone,

Thank you to Districts 5 and 22 for a wonderful Assembly/Convention in Lake Placid. I loved looking out at those mountains and Mirror Lake every morning and am grateful to have seen the double rainbow on my first night there.

I will highlight what I went over in my report at the Assembly and will start with the most recent news that I received this week from WSO:

- It was announced at Conference that as a follow-up to the ***Having Had a Spiritual Awakening*** e-book (eB-25), an e-book edition of ***How Al-Anon Works for Families and Friends of Alcoholics*** is planned to be available this summer through electronic book providers. An audio version of this book is also planned to be available this summer in MP3 format through electronic audio providers. I have been told that since 2012 the World Service Office (WSO) has gathered substantial data that electronic literature does not impact the sale of hard copy books. Nonetheless, the WSO will continue to monitor the sales of the electronic and hard copy version of this book to determine whether there is a negative impact on the fellowship. The WSO hopes that on the contrary, the electronic version of ***How Al-Anon Works*** will bring more awareness of the program to the public and those in need.

- Another new service tool, **Conflict Resolution Cards Using Our Twelve Traditions (S-72)** is \$4. They can be ordered now. They just arrived at WSO from the printer and they will be shipped as soon as they are assembled.

- There is a price increase on some of our Literature effective May 1st. This increase will be on most items, including previously free items. Our last price increase was in 2006. The most recent order forms (S-15) can be found on the Members' site, www.al-al-anon.org/members

- Our Legacies Workbook has a name; ***Reaching for Personal Freedom—Living the Legacies*** (P-92). This book is spiral bound and similar in size to our ***Blueprint for Progress*** but longer, 176 pages. It will be available after the International Convention in Vancouver and the cost will be \$15.

- Our ***Service Manual*** 2014-2017 (P24/27) will be coming out in early 2014.

The sharing sheet for ***INTIMACY IN ALCOHOLIC RELATIONSHIPS*** (working title) can be found on the NYN website nynafg.com or at the Members' site under "Submit a Personal Sharing." Please encourage more

members to share on the many types of intimacy, including sexual intimacy. There is no deadline for these sharings at this time.

- Please remind members that the soft cover edition of ***How Al-Anon Works (B-32)*** is intended for members and groups to give to newcomers. The cost of this book is now \$6.

Our topic for this month is "Principles above Personalities." I like the reading in ***Hope for Today*** on p. 356 on our 12th Tradition, "Anonymity is the spiritual foundation of all our Traditions, ever reminding us to place principles above personalities." This Tradition means that "We are all equals—experts only in sharing our personal experience, strength, and hope. Remaining anonymous about my economic class, social status, or current employment helps me maintain that sense of equality." Further on: "Freed of worldly constraints, our principles, as practiced in the meetings, provide a secure environment where we can heal and grow spiritually as equals." I find this to be a particularly important, humbling experience. The last paragraph in this reading is something I also find important. It says, "If I'm not looking eye-level at my fellow members, it's time for me to take a look at myself." And finally, "Anonymity unifies our fellowship by removing individual status so we can listen to the message rather than the messenger." This is the challenge—principles above personalities!

Having returned home with a new sense of "WONDER" from four serene days in Lake Placid, I sit here writing to you about Archives from the perspective of the World Service Office (WSO).

My goal is to link you to the WSO website and to the Archives material.

This month, I would like to highlight the [AR-9](#) Request for Research feature...a feature I hope to have up and running for New York North (NYN) in September.

Below is the information stating the purpose of Archives at our WSO level of service:

Look to the Past to Protect the Future—Al-Anon's World Service Office Archives

"...It is so important to keep Al-Anon alive and to keep past growth as well as future growth," Lois W., Al-Anon Co-founder.

The WSO Archives is the repository of the documented historical record of Al-Anon fellowship. The historical record starts at the beginning of the movement and documents the milestones of growth towards the presence of the fellowship today in countries around the world. Special emphasis is placed on preserving the records of Al-Anon's founders, early groups, beginning days of the [Clearinghouse](#) and the organization of Al-Anon Family Group Headquarters, Inc.

The theme for this month's *Northern Hi Lights* is "Principles Above Personalities."

From (P-78) *When I Got Busy, I Got Better*, p.28-29, I am reminded that..."when I am able to focus on common tasks without being distracted by individual differences in personality or opinion...and concentrate on simply doing the best I can without glorifying my successes or failures, I am living a lesson of acceptance."


