The newsletter committee met on 4/10/23 to discuss preliminary ideas. We will meet again to continue the discussions. We reviewed recent newsletters, the newsletter mission statement, and the WSO document number G-12, "Guidelines for Newsletters" which we found very informative. No decisions were made. However, the following ideas came up.

- In general, the purpose of the newsletter is to inform and communicate. Examples of useful information to be conveyed are:
 - Issues to be discussed at upcoming assemblies, including special notice of "hot items,"
 - The election of officers every three years, including descriptions of each position,
 - Officer and coordinator reports and news,
 - Encourage attendance at service events,

- Attract members into service positions,
- Local, Area, AIS, and WSO news.
- We reviewed the "sharing" articles on the topic of the month, which we regularly publish, which have no news or information content. We believe they would be more appropriate to be published elsewhere, such as in the "Forum", which is dedicated to "sharings", rather than in the NYN newsletter. In lieu of several "sharing articles," there could be a single monthly "column", dedicated to a different topic each issue, written by a different author each issue.
- We anticipate proposing changes to the newsletter editor job description, and the newsletter mission statement, for consideration by NYN.

Topic: "Calming Oneself Down"

Calming oneself down.... is easier said than done! I know that the years I spent wallowing in the frustration, anger, and resentment of my son's addictions were not easy to digest. I had built up so much negativity that calming techniques were the farthest thing from my mind.

Over the years since I entered the rooms of Al-Anon, I have found solace and serenity in my program. That journey of finding the ways of calming me down was not an easy path to follow, and there were quite a few speed bumps on this road of life.

I do acknowledge that a major source of calm is found in the *daily readers*. It always seems to come to fruition that the message or direction I needed on that particular day was located right in the pages of that missive for the day. Call it coincidence or your Higher Power, but it is true!

Another way to calm yourself down is to seek out the wisdom of your *fellow members* in Al-Anon. They often can find a soothing word or a calming presence to alleviate the negative aura that surrounds you on that particular day, and most of my closest friends in my Al-Anon family have been there and done that, so you can trust in their words of experience, strength, and hope.

Several of my friends point out the calm they find in *distraction*. Instead of focusing on the bad thing that is flitting around in your head, look for calm and diversion in doing the things you love to do: working in your garden, riding a bike, watching your favorite movie (again), or reading a book. That last distraction has served me well over the years. A fun thing I enjoy doing is keeping track of the pages I read in a particular year, just for the pleasure of knowing what I have done instead of worrying about or fixating on my son's

problems. I started doing that back in 2002, and I have hit over 100,000 pages a few times. This year, I counted up the total pages read over the last twenty some years, and realized that I have surpassed a milestone of one million pages!

Whatever works best for you, look for what calms you down and use it to your advantage. Remember to take what you like and leave the rest!

Calming oneself down.... A most obvious warning sign that something is awry is when my heart beats out of control! That's my cue to calm myself down, or else! ... Trying to figure out how to do that is key.

BA (before Al-Anon) I used to avoid as much confrontation as possible, not only with my loved one, but at work, with my children, my sister and parents. I almost always dreaded the processes of a problematic situation. Why? Because chances are I didn't have control. I would always be the one to compromise. And that made me angry. In Al-Anon, I have tools, techniques, that come into play when my heart rate accelerates.

Most of the underlying stress causing my anxiety has been drastically reduced, thankfully. But when it does happen, I take a deep breath, recite the Serenity Prayer, remember the 4 C's, and try to regain what I do have control over....ME!

Music influences my quick recovery. Pounding soil in my garden and talking to myself really helps. In the winter, I shovel snow. Fresh air, cold or warm, makes me feel alive and thankful. I am able to calm down,

- By Kathi D. – Delegate's Report from the World Service Conference (WSC)

Cindy M, WSO Treasurer, delivered a presentation at the WSO Conference, on the Seventh Tradition – "Every group ought to be fully self-supporting, declining outside contributions." Her presentation started with quotes from Lois, "It's all spiritual", "Let it begin with me" ... by making individual contributions. Keep in mind, the WSO needs to be fully self-supporting, just as our own groups are, through the combined contributions of all Al-Anon groups that are supported by the WSO.

She addressed some myths concerning how groups should contribute the WSO. -- For example, ONE MYTH is: "Give close to home the most." She suggested a better way is to distribute excess funds based on the cost per group of each service arm. -- This is done by dividing the current annual budget by the number of groups, see explanations and examples below.

This leads to the following questions & answers. (These answers are explained in the charts that follow. Each group will have its own variations.)


Question:	Answer:	
► Individual Group: What should each group contribute to the WSO per year?	• \$321.25 (minimum)	
► Funds Distribution: What are the percentages to be distributed to each "service wing"?	• WSO = 54% • NYN = 14% • AIS = 18% • District = 14%	
Each Member: How much should each member contribute to home group?	• \$3.15 per week (*) (per example below)	

Funds Distribution Example: (*) (each group is different). The percentages to contribute to each service arm are calculated below. When distributing excess funds, the computed percentages should be used to determine the amount given.

The Changing Spaces of Al-Anon Groups – The new Global Electronic Area, "GEA" – (Article from the WSO.)

Since the spring of 2020 and the onset of the COVID-19 pandemic, the continuous and sometimes tumultuous changes in our world have directly impacted our Al-Anon groups.

The 2022 World Service Conference (WSC) made history by voting to accept the Global Electronic Area (GEA) as the 68th Area connected to the WSC Structure.

New choices are now part of the discussion, for instance, whether to meet in person, online, or include an electronic component with an in-person meeting (hybrid). Important considerations:


- If your Area does not yet have a process in place to accept electronic Al-Anon groups, please consider participating in District and Area discussions about establishing one.
- If your in-person group moved temporarily online during the pandemic and some members now wish to remain online, these members simply need to register a new electronic group.
- If all the members wish to remain online, you can update your group information to change your location from physical to electronic.

- Electronic groups can either register as connected to a geographic Area to attract a local audience (provided the geographic Area has a process in place to do so) or register with the new GEA to attract a global audience.
- Groups that are already registered with the GEA can now request a transfer to a geographic Area (and vice versa) by using the appropriate "Group Area Transfer Form." Go to al-anon.org/egroup-transfer to get the forms.


The goal of completing updates is to ensure the WSO and service arms are able to provide accurate meeting information. Newcomers seeking help and hope should be able to look at a meeting display and know when, where, and how to attend.

Every member participating in an Al-Anon group is responsible for the accuracy of their group display on al-anon.org. Consider taking a moment to check it now, and if anything is inaccurate, please update the group meeting information by going to **al-anon.org/groupupdate** and selecting the appropriate Al-Anon Group Change Form.
