During my Spring Assembly report I spoke about next year's, 2015 search for a Northeast Regional Trustee. Again it is not too early to be thinking about this. The resumes will be due in to the WSO in August 2015. In order to meet this deadline the NYN assembly would need to approve a candidate at the 2015 Spring Assembly.
