

The 1016 NYNAC ran from October 7th – 9th, 2016. This event was held at Vanderkamp Center in Cleveland, NY. This seems to be a popular venue with the Alateen members as well as the sponsors and AMIAS's.

The cost of lodging was \$3540.00. There was an additional cost of a little less than \$300.00 which was paid at the end of the event. (I rounded the check up to \$300.00) This was not an unexpected cost. This was for "additional fees that apply to custom menu planning (allergies, etc) as well as the coffee and tea service.

The registration for each participant was \$125.00. I believe we can keep it the same or even lower it for 2017! The registration fee included the cost of t-shirts.

Groups and individuals were very generous with their donations. I am overwhelmed with this response! At this time we have no outstanding debts, including the seed money, and we have a balance of \$2,798.47 in the NYNAC account. At this time I do not have the total breakdown of income and expenditure, but I will have that at the May Assembly/Convention.

I have received information from Vanderkamp with new pricing. It looks like there is a possibility that we could still afford two cabins and keep the price down. The possibility of renting just one cabin could be considered, saving approximately \$700.00. Vanderkamp has no "minimum limits" for use of the facility.

I have received conflicting feedback from teens and adults alike about this NYNAC. Some of the teen members did not really feel comfortable with the large number of adults at this event, and others did not seem to have much of a problem with it. For the most part, everyone was pleased with the menu, and others wanted "more mashed potatoes". Although there was an area set aside for those to attend a movie instead of the dance, some who attended did not realize this. I will try to address this issue for the 2018 NYNAC.

I still have to get the duty folders handed out, and hope to have them ready to go by May's meeting. There was some overlap of responsibilities in the folders, which created some very minor confusion at NYNAC. The sponsors and teens did a great job of conflict resolution.

I am very proud of the way our entire group presented themselves at NYNAC. Vanderkamp would love to have us back. That speaks volumes! I have checked with other venues, and so far have found only one that is available the weekend we would like. Consideration of changing the weekend is not out of the question, but I don't think that it will be necessary. The one venue that is available this week end is more costly than Vanderkamp.

*NOTE: The balanced financial report will be available in May. At this time there is a \$5.00 discrepancy between my accounting and the bank's balance. I probably entered one \$5 item twice.

As of today, Stacie Eriksson at M&T Bank is now researching my claim of lost or misdirected funds in the amount of \$287.05 that the teens raised at the 2016 Salt City Mid-Winter Roundup. I will report on that as soon as I have anything to report.
