viii) Ask-it-Basket: Delegate's Report Elaine, Margo and Barb.

1) Q: With 2 million in WSO salaries I am wondering what happened to "forever non-professional" Not to

mention "post-retirement" health benefits.

A: Barb With regards to 2 million in WSO salaries. No sure if that is correct amount. There are 50 people.

WSO is incorporated, a business. People employed are professionals. Retirement benefits are part of benefits.

Finance committee meets regularly, nothing is taken lightly. The Executive Director is very frugal.

2) Q: How do I know that when I contact a facility as part of Public Outreach and give my name, address

and phone number that they will know I chose to remain anonymous at the level of press, radio, TV and

films?

A: Margo You're going to tell them that. Explain policy of anonymity.

3) Q: Can we openly invite participation of people who love other addicted people? Can we get a glossary

of terms for new comers?

A: Elaine We don't make the decision if you belong in Al-Anon, the person does. There is a bookmark made

a few years ago with terms, also can be found in Service Manuel.

4) Q: What is the email address for Resource Questionnaire? Why are the last names mentioned in WSO

Report materials?

A: It is on member's website, to email <u>WSO@al-anon.org</u>, subject question. When you become a delegate

or above using your last name does not break tradition. We are not anonymous within the fellowship.

5) Q: What time frame are the donations to WSO? Now or last year (2008 or 2009)?

A: Margo I don't understand the question, what's printed is 2008.

6) Q: May the "love gifts" be from individual groups, not just districts? (for delegates to WS Convention)

A: No problem, anyone who wants to can.

7) Q: Would you like to have the group members asked to fill out the on line survey or is it for GRs?

A: Barb It is for everyone.

8) Q: Where does the money come from to make up difference in income and expenses in WSO budget?

A: Margo Money can come from reserve funds. Can have an unbalanced budget.

9) Q: Can you explain Forum problems? How does the problem apply to individuals and groups?

A: Elaine The number of subscriptions are down. Not certain at this time why they are down. We are

an older population, younger population gets information in different ways. There is a lot of information

that needs to be gathered before anything plan of action can be developed.

10) Q: You said 130 countries had Al-Anon. How many countries sent delegates to the WS Conference this

year?

A: Delegates are not from other countries. They have their own conference structure. They may send a rep.

WS Conference. 67 Delegates from Canada, US, PR and Bermuda. There were 4 reps.

v) Clarification on PA Alateens attending NYNAC – Discussed at last night's AWSC. Each area has it's own

guidelines. Per WSO as long as other areas guidelines are equal to or greater than our own guidelines it would

be OK for another area to attend NYNAC. In this case PA's guidelines are greater than NYN. PA Alateens

will be able to attend NYNAC.

vi) Clarification on fundraising for Assemblies and Conventions – We don't want to infringe on another host district.

Decided that next host committee can begin to fund raise at an assembly or convention beginning on Saturday PM.

Will be written down in policies.

vii) Purchase of audio equipment – Not all hotels are providing audio equipment when an assembly or convention

is held. It is expensive too rent equipment. It would cost about \$600 to purchase, we have \$500 in budget for the

purchase of equipment, we have purchased external hard drive and DVD player. It is also possible other monies

would be available. Contact Connie with comments, concerns etc. Will discuss at next AWSC. Note it will cost

\$250/day at the fall assembly to rent audio equipment. No motion at this time as has to be brought to AWSC.

Q: Can we begin fund raising for 2019 Spring Assembly and Convention now? Fund raising at his time should not

Be done at convention, maybe at group, district level.

- Q: Didn't we have an AD HOC committee to discuss the structure of conventions? The AD HOC is Long Range Planning for Conventions and Assemblies.
 - Q: How do we get added to an AD HOC committee? Just need to attend a meeting.
- Q: How do you find out about a meeting? Check Northern HiLights for meeting announcements.
- Q: Shouldn't host districts only book places with audio equipment? May not be able to, affordability an issue.

Equipment could also be used at AWSC meetings.

Q: Can NYN accept earmarked donation? WSO does not allow earmarked donations. Unknown about at area

level. If we model WSO then would not be allowed.

Q: Clarify if vote on equipment would be at AWSC or Assembly? As there is \$500 in budget if under can be at

AWSC, if over at assembly. Need to research audio equipment, KBDM.
