DISTRICT 1 - ALL OF ERIE COUNTY NORTH OF AND INCLUDING THOSE TOWNS AND CITIES SITUATED ON ROUTE 20, NORTHERN PART OF THE CITY OF BUFFALO AND THE CITY OF NORTH TONAWANDA

DISTRICT 2 - MONROE COUNTY WEST OF THE GENESEE RIVER

DISTRICT 3 - ONONDAGA COUNTY NORTH OF INTERSTATE 90

DISTRICT 4 - ALL OF JEFFERSON AND LEWIS COUNTIES; HERKIMER COUNTY NORTH OF ROUTE 28

DISTRICT 5 - ALL OF CLINTON AND ESSEX COUNTIES; HAMILTON COUNTY NORTH OF ROUTE 28; FRANKLIN COUNTY EAST OF ROUTE 30 INCLUDING ALL TOWNS AND CITIES SITUATED ON ROUTE 30

DISTRICT 6 - MADISON AND ONEIDA COUNTIES EXCEPT FOR CHITTENANGO AND THAT PART OF HERKIMER COUNTY WEST OF ROUTE 28 AND A LINE EXTENDING FROM POLAND TO ONEIDA/HERKIMER COUNTY LINE

DISTRICT 7 - ALL OF RENSSELAER AND COLUMBIA COUNTIES

DISTRICT 8 - ALL OF SCHENECTADY COUNTY SOUTH OF THE MOHAWK RIVER; ALL OF ALBANY, GREENE AND SCHOHARIE COUNTIES

DISTRICT 9 - ALL OF CHENANGO COUNTY EXCEPT FOR THE TOWN OF GREENE; ALL OF DELAWARE AND OTSEGO COUNTIES

DISTRICT 10 - ALL OF CORTLAND, TOMPKINS, TIOGA AND BROOME COUNTIES AS WELL AS THE TOWN OF GREENE IN CHENANGO COUNTY

DISTRICT 11 - ALL OF STEUBEN, CHEMUNG, SCHUYLER AND YATES COUNTIES BELOW THE TOWN OF PENN YAN

DISTRICT 12 - ERIE COUNTY SOUTH OF ROUTE 20; SOUTHERN PART OF CITY OF BUFFALO, TOWN OF DUNKIRK AND FREDONIA

DISTRICT 13 - NIAGARA COUNTY WEST OF ROUTE 425 WITH THE EXCEPTION OF THE CITY OF NORTH TONAWANDA

DISTRICT 14 - MONROE COUNTY EAST OF THE GENESEE RIVER AND SOUTH OF ROUTE INTERSTATE 490; LIVINGSTON COUNTY NORTH OF ROUTE 20

DISTRICT 15 - ONONDAGA COUNTY WEST OF INTERSTATE 81 AND SOUTH OF INTERSTATE 90

DISTRICT 17 - CHAUTAUQUA, CATTARAUGUS AND ALLEGANY COUNTIES EXCEPT FOR DUNKIRK AND FREDONIA

DISTRICT 18 - ONONDAGA COUNTY SOUTH OF INTERSTATE 90 AND EAST OF INTERSTATE 81; MADISON COUNTY WEST OF ROUTE 13 INCLUDING SHEDDS, NEW WOODSTOCK, DERUYTER, CAZENOVIA AND CHITTENANGO, NORTH OF THE ONONDAGA/CORTLAND COUNTY LINES

DISTRICT 19 - MONROE COUNTY EAST OF GENESEE RIVER TO ROUTE 590, NORTH OF ROUTE 490

DISTRICT 20 - LIVINGSTON COUNTY EAST OF THE GENESEE RIVER AND SOUTH OF ROUTE 5 AND 20

DISTRICT 21 - ALL OF OSWEGO COUNTY

DISTRICT 22 - ALL OF WARREN, SARATOGA, WASHINGTON COUNTIES; SCHENECTADY COUNTY NORTH OF THE MOHAWK RIVER

DISTRICT 23 - NIAGARA COUNTY EAST OF ROUTE 425 AS WELL AS ALL OF ORLEANS COUNTY

DISTRICT 24 - ALL OF MONTGOMERY AND FULTON COUNTIES; HERKIMER COUNTY EAST OF ROUTE 28 AND A LINE EXTENDING SOUTH FROM POLAND 20 ONEIDA/HERKIMER COUNTY LINE AND SOUTH OF E-W 28

DISTRICT 25 - MONROE COUNTY EAST OF ROUTE 590, NORTH OF ROUTE 490 AND ALL OF WAYNE COUNTY

DISTRICT 26 - ST LAWRENCE COUNTY AND FRANKLIN COUNTY WEST OF ROUTE 30

DISTRICT 27 - ALL OF LIVINGSTON COUNTY WEST OF THE GENESEE RIVER; ALL OF GENESEE AND WYOMING COUNTIES

DISTRICT 28 - ALL OF SENECA COUNTY EXCLUDING THE CITY OF GENEVA, BOUNDED ON THE EAST BY THE ONONDAGA COUNTY LINE, ON THE WEST UP TO THE CITY OF GENEVA, ON THE NORTH BY THE NEW YORK STATE THRUWAY, AND ON THE SOUTH BY THE CAYUGA COUNTY LINE AND THE SENECA COUNTY LINE

DISTRICT 29 - ONTARIO COUNTY NORTH AND SOUTH OF ROUTE 5 AND 20 INCLUDING THE CITY OF GENEVA, ONTARIO COUNTY NORTH AND SOUTH OF THE NEW YORK STATE THRUWAY (ROUTE 90) AND PENN YAN IN YATES COUNTY
