A topic up for discussion at the WSC – World Service Conference is the possibility of including virtual meetings in the WSO structure. I have zero experience beyond face to face meetings. I decided to change that fact. In 2001, the WSO started registering online meetings, and in 2007, phone and other electronic meetings. Electronic meetings offered Al-Anon members a means of connecting and sharing the Al-Anon program regardless of location. By 2018 there were over 25,000 groups in 133 countries and 107 electronic (digital, social media and phone) meetings.
