#### **Secretary's Report** – Minutes are posted on the NYN web site.

The minutes from the 2023 Fall Assembly of September 30<sup>th</sup> was read by Acting NYN Secretary Molly C. Questions were asked and answered about the defeated motion to donate NYN funds in memory of a past delegate and the monies in the Sage Mutual Fund.

Two corrections were made:

#### Treasurer's Report -

#### We have no treasurer - please consider this position.

Delegate Carol C has been depositing and writing checks as needed and posted the Financial Report Jan-April 2024. The 2023 year-end reports from former Treasurer Betty GM are also posted on the NYN web site.

Current NYN Area Assembly Account Statements as of May 16,2024

General Operating Fund \$19,320.49 Reserve Fund \$14,845.64 NYNAC fund \$ 1,207.40

NYN's 2024 budget for NYNAC Seed money for Panel 64 is \$1500.00. That requires a \$292.60 transfer into the NYNAC account.

Delegate Carol also noted that the Actual Expenses for 2023 was \$ 9,755.04 and the 2023 Revenue was \$ 11,210.16. The 2024 Budget approved at the 2023 Fall Assembly allows \$25,650.00 in expenses and \$14,845.64 in the Reserve account. Actual travel expenses will be less with decreased travel expenses due to the virtual only and the hybrid assemblies scheduled. The 2023 newsletter publishing expenses are listed as \$ 0.00 is not an accurate reflection of costs.

NYN Area has a PayPal account but there is no Treasurer to use it so all donations or event registrations must be mailed to the Area PO Box. There is no rent paid by the NYN area.

This included an Al-Anon/Alateen Service Manual Study and reading Lois Remembers (B7) and Many Voices, One Journey (B31).

A Google slide presentation covered the links of service, many acronyms used in Al-Anon and the Al-Anon Service Structure.

#### Alternate Delegate and Forum Coordinator - Betty GM

Betty reports meeting the WSO Forum Coordinator and those of other areas at a meeting. Sharing their experience, strength and hope including many ideas to increase Forum sales. She is receiving information through the AFG Connects community regularly.

#### Immediate Past Delegate - Kathi D

To date, I have written one Northern HiLight article, attended the Winter AWSC meetings, and held the New Group Representative (GR) Orientation meeting. New GRs attend to learn what to expect at their first assembly and to go over what the job entails. Any GR or AFG Member is welcome to attend. These meeting are held prior to each assembly.

#### **Alateen Coordinator** – Mary S (interim)

- The Alateen Coordinator works with the Area Alateen Process Person (AAPP) to recertify all Al-Anon Members In Alateen Service (AMIAS) and to support Alateen groups. There is an Alateen Interest Meeting held prior to each assembly for members interested in service to and locating an Alateen group in NYN.
- We are currently looking for male AMIAS to support Alateen and follow our safety guidelines for Alateen events.
- There is a new "Summary Guide for Mandated Reporters in New York State" posted as Attachment J of the NYN Area Alateen Guidelines.

#### Area Alateen Process Person - Vicky D

- We have lost 14 AMIAS this year for various reasons. There are 7 recertifications still in process. There are 11 Alateen groups in the NYN Area.
- Many areas are trying to increase the number of Alateen meetings. WSO is
  trying to set up guidelines for electronic Alateen meetings that are safe for its
  members. Some GSOs (General Service Offices) of other countries already
  have electronic Alateen meetings set up. There are currently 5 Alateen meetings
  available on the Al-Anon app for tablets and smart phones set up on a trial basis
  to work out any kinks.
- Remember that Alateen is Al-Anon and Alateens are welcome at any Al-Anon meeting
- Noted by Loron O Rochester AIS: The number of AMIAS is down from 52 to 38 and YET no active Alateen group has been affected by the decline.

#### Newsletter Coordinator - Wendy L

Wendy thanked former Newsletter Coordinator David N , proof readers, mail help for their service in getting out the newsletter. Around 55 people get the hard copy through the mail. Printing and postage, at an average of about \$100 per issue, have been almost twice what we budgeted. Postage is going up again in June. There was a previous decision to ask everyone who gets the newsletter by mail to re-subscribe each year at a certain time of year, so we do not send out to folks who no longer want it. This has not been done, but we plan to do it this year. The finance committee is being asked to consider what the amount of the suggested donation will be. Meanwhile, we have an email list of 414 people, and some folks are complimenting the layout. I want to get a clearer vision of how many people from our email list open the attachment and value the content.

#### **NYNAC Coordinator** - Mary S

At the current time, NYNAC has been put on hold until the AAPP has finished the recertification process. We need male AMIAS for supervision at NYNAC. If you are at least 21 years old, have two years of consecutive Al-Anon membership and would like to share the gift of recovery with teenagers, please consider stepping into service. AMIAS must be certified by the area in which they serve. A NY South AMIAS cannot serve in the NYN Area Alateen service.
